**POSITION DUTIES:** This is an entry-level coordinator position for a licensed Mental Health Professional to coordinate GAP: Youth and Family Services. Work with individuals and families of various ethnic backgrounds to promote optimum mental health. Help individuals deal with family issues, stress management, and mental and emotional health-related problems. Maintain professional mental health records. Assess clients' physical, mental and emotional condition based on Diagnostic Assessment and coordinate services with different service providers. Provide clinical supervision to graduate level interns. Provide counseling services to clients (adolescent and young adults age 13-24) and families to assist in overcoming conflictual relationships, adjusting to life changes, and making successful changes. Guide clients in the development of skills and strategies for dealing with their issues. Client population is approximately 33% African-American, 33% Hispanic, 33% Asian, Native-Americans, and Caucasian. Position involves approximately 33% of time supervising graduate student interns, 33% of time handling intensive in-home cases, and 33% counseling GAP clients on-site. Travel limited to Twin Cities metro area.

**POSITION REQUIREMENTS:** Requires a Master's degree in Marriage and Family Therapy or Psychology. Qualified candidate must have a valid Minnesota license as a Marriage and Family Therapist. Qualified candidate must have at least 24 months experience organizing counseling events and providing mental health counseling services for individuals and groups, including experience counseling students, families, victims of domestic violence, and at-risk youth between the ages of 13 and 24 of various ethnic backgrounds. Experience may be gained as a Mental Health Practitioner or Mental Health Professional. All experience may be gained concurrently.


